# Instructions For Off-Premise Application

Licensing a business to sell and serve alcoholic beverages is a cooperative effort. It begins with information provided by the Applicant, and is followed with investigation of the Applicant and the proposed premise by law enforcement officials, inspections by the health and fire inspectors, approval of the license by the local official, and is completed with issuance of the license by the Iowa Alcoholic Beverages Division.

Following is a brief outline to assist with the completion of the Application:

#### **GENERAL INFORMATION**

All questions shall be completely answered and payment attached. Submit a signed copy of the lease/rental agreement for the license period or a signed final sales contract or warranty deed. Thoroughness in completing the Application will assist the Local Authority and the Alcoholic Beverages Division in processing the Application without delays. Please enclose payment with the Application (fee chart attached).

As a condition to receiving a license, the Applicant's premise is subject to inspection during business hours by appropriate local, state and federal officials.

False representation of material fact in the application is a serious misdemeanor crime and grounds for denial of the license or permit under Iowa law.

Please contact the Iowa Alcoholic Beverages Division with any questions at 866/469-2223. The Division's office hours are from 8:00 a.m. to 4:30 p.m. Monday through Friday.

#### LICENSE CLASSIFICATIONS PRIVILEGE

> Class C Beer Permit: Allows commercial establishments to sell carryout beer

and wine coolers in original unopened containers.

> Class E Liquor License: Allows commercial establishments to sell carryout liquor

in original unopened containers. The license includes

Sunday Sales Privilege.

> Class B Wine Permit: Allows commercial establishments to sell carryout wine

in original unopened containers. The license includes

Sunday Sales Privilege.

Commercial establishments may hold any combination of the above-mentioned licenses.

#### ADDITIONS TO LICENSE

# **PRIVILEGE**

> Sunday Sales Privilege:

Allows selling and serving of those alcoholic beverages permitted by the license or permit from 8:00 a.m. on Sunday to 2:00 a.m. the following Monday.

> Living Quarters Permit:

Separates living quarters, accessible from inside the licensed premise, from the licensed premise and protects residents from warrantless searches.

## **CARRYOUT LICENSE FEE CHART**

### Class C Beer Permit: Fees are calculated on the interior floor space of the retail sales area.

<sup>\*</sup>Class C Beer Permit fees are payable to the local authority. Sunday Sales Privilege on Class C Beer Permit, and all other fees, are payable to the Alcoholic Beverages Division.

<u>Class E Liquor License:</u> Fees are calculated on a sliding scale factoring square footage and population. Sunday Sales Privilege is included.
