## Coordinator's Report

Mike Kennon reported on the corn ethanol plant that will be located on the north edge of Atlantic and is scheduled to be operational by mid-2018. The plant will have the capacity to produce 120 million gallons of ethanol/year. Kennon intends to add a general outline of what we know about the facility to the County Hazardous Materials Plan immediately and fill in additional details as they become available.

Kennon reported that he was working on annual updates to the Cass County Comprehensive Emergency Management Plan. The County Hazardous Materials Plan and three other ESF sections of the County Emergency Operations Plan will be presented to the EMA Board for their approval at the July meeting.

Kennon took part in a Cass County Sheltering Table Top Exercise with County Coalition partners on April 6<sup>th</sup>. Cass County Public Health, Cass County Health System, Cass County EMA, Iowa Red Cross and State Public Health representatives discussed various scenarios which would likely present great challenges for our local sheltering capabilities. The sheltering TTX fulfills some annual exercise requirements for Cass Co EMA. It also had the added benefit of clarifying emergency response responsibilities and expectations with our new PH director, Beth Olsen.

Kennon plans to attend the U of O Emergency Management Conference on May10-12 as well as the Region VII LEPC/TERC Conference on July 20-22. These conferences offer much of the continuing education credits required for the year and most expenses for these particular conferences is reimbursed.

Finally, Kennon talked about a project he has led to equip the courthouse and secondary roads vehicles with first-aid kits, first-aid supplies and trauma kits. These supplies will be paid for thru a reimbursement grant from our insurance carrier, ICAP.
