PUBLIC NOTICE

The Cass County Board of Supervisors is hereby giving its notice of intent to establish Cass County Ordinance No. 19-2021 entitled "An Ordinance Establishing the Election Precincts in Cass County, Iowa".

A public hearing on the intent to establish this ordinance will be held in the Boardroom of the Courthouse, Atlantic, Iowa with the first consideration to be held at 9:00 a.m. on January 7, 2022. The intent is to waive additional considerations and take a final vote for or against passage after the first consideration.

The proposed ordinance reads as follows:

Ordinance 19-2021 – Election Precincts

Title. An Ordinance Establishing the Election Precincts in Cass County, Iowa.

<u>SECTION 1. Purpose</u>. The purpose of this ordinance is to establish the election precincts in Cass County based upon population figures of the 2020 federal decennial census in accord with **IOWA CODE** Section 331.210A and Chapter 49.

SECTION 2. Election Precincts. In accord with sections 49.3, 49.4, 49.6 and 49.8 of	the Code of Iowa.
Precinct 1 shall be comprised of Atlantic Ward 1	(population 1,488)
Precinct 2 shall be comprised of Atlantic Ward 2	(population 1,324)
Precinct 3 shall be comprised of Atlantic Ward 3	(population 1,336)

Precinct 5 shall be comprised of Atlantic Ward 5	(population 1,310)
Precinct 6 shall be comprised of the townships of Bear Grove (198)	
and Cass (234) and the city of Lewis (357)	(population 789)
Precinct 7 shall be comprised of the townships of Benton (163) and	
Franklin (202) and the city of Wiota (91)	(population 456)
Precinct 8 shall be comprised of the townships of Brighton (172), Grove (343),	
Pymosa (295) and Washington (215) and the city of Marne (110) and excluding	<u>.</u>

Precinct 9 shall be comprised of the townships of Edna (96) and Victoria (132) and

SECTION 3. Effective Date. This ordinance shall be effective on January 15, 2022, after its final passage, approval and publication as provided by law.
