## Tuesday, July 19, 2022 Minutes

The Cass County Board of Supervisors met at 9:00 a.m. with all members present: Steve Baier chair; Stephen Green, John Hartkopf, Mark O'Brien and Bernard Pettinger. Agenda upon motion by O'Brien; 2nd by Pettinger was approved. Minutes of July 12, 2022, upon motion by Hartkopf, 2nd by Pettinger were approved.

Jotham Arber with Cass/Guthrie Co. Environmental Health presented the quarterly report through June 2022 and an Environment Health Cost report. Arber stated there have been a number of PERC tests and well cleanings. He also stated that they are beginning pool inspections.

Trent Wolken, Cass County Engineer, presented Resolution 2022-037 to Vacate Excess Right of Way. The area lies around bridge 319 and is more than what is needed. He would like to vacate and then purchase right of way that is needed for the bridge project. Trent presented that this is technically an easement that has never been utilized and there is no bearing on the current bridge. The board would like to table this resolution until Trent is able to speak with the land owner.

Trent Wolken, Cass County Engineer, presented updates for Secondary Roads. NRCS moved to accept a bid from Jorgensen Dirt Works for the Crooked Creek project. This will need to be an agenda item for the next board meeting on 7/29/22.

Lewis City Council approved rural resident Nadine King to the Lewis Library Board. Motion to approve by Hartkopf; 2<sup>nd</sup> by Green.

Committee Reports: Green – still working with City of Atlantic in regards to Animal Shelter research. Baier noted that the Cass County Fair begins next week.
