## Wednesday, August 31, 2022 Minutes

The Cass County Board of Supervisors met at 9:00 a.m. with members present: Steve Baier, Chair, Stephen Green, John Hartkopf, Mark O'Brien-Vice Chair and Bernard Pettinger. Agenda upon motion by Mark O'Brien; 2nd by Steve Green was approved. Minutes of August 23, 2022, upon motion by Bernard Pettinger, 2nd by Steve Green were approved.

PUBLIC COMMENT: the Board of Supervisors were asked questions regarding the county owned farmland. Board Char, Steve Baier, encouraged his fellow board members to reach out to the community for ideas on the decision of either selling or keeping the land, and how to utilize the funds. The board agreed that regardless, the funds would be put toward public purpose i.e., mental health awareness, economic betterment, housing development.

Cass County Engineer, Trent Wolken, presented secondary roads reviews and updates.

Motioned by Steve Green; seconded by John Hartkopf to approve Bridge #32 funding. Bridge #32 is located on 680<sup>th</sup> over the West Nodaway. The \$1.1 million dollar project will be funded 100% by the Highway Bridge Program. Carried unanimously.

Sale of County Owned Farmland- the Board listed this as a discussion item to keep the conversation open about what feedback they are receiving from the community on how to handle the land. Since there was discussion during the public comment, no further conservation took place.

Cass County Conservation Restroom Construction Project – Conservation Director, Micah Lee, presented three different options for a public restroom in the main parking lot of Cold Springs Park in Lewis. The Conservation board will be contributing to the project and were seeking a financial contribution from the board. The board agreed to help fund the project but asked Micah to speak with the Conservation board about providing a budget and more information that the Board can review. Micah will present more details at a later date.

Motion by Bernard Pettinger, seconded by John Hartkopf: to approve the application for a Renewal Class C Beer Permit and Sunday Sales. Privilege effective 10/18/2022 of 21st Century Cooperative (74515 Richland Road, Massena, IA). Carried unanimously.

Discussion on county issued credit cards- the board discussed how many cards each department has, how many each department needs to operate, and would like to continue the conversation as there are some consistent issues of misuse. The discussion was tabled and will reviewed again in future meetings. Future use of zoom for board meetings – some board members expressed they do not mind the meetings being broadcast on zoom, as it is beneficial to constituents who cannot attend the meeting in person, when needing to present to the board. It was suggested to speak with our HR Attorney, Mike Galloway, with Ahlers Cooney Attorney's, to seek advisement on this topic. The board will revisit this topic at a later date. MH/GA Report July 2022- Director, Debbie Schuler, presented updates and an overview report for July's activity inside the Mental Health/General Assistance department.
