Tuesday, September 13, 2022

The Cass County Board of Supervisors met at 9:00 a.m. with all members present: Steve Baier chair (arrived at 9:15 a.m.); Stephen Green, John Hartkopf, Mark O'Brien and Bernard Pettinger. Agenda upon motion by Green; 2nd by Pettinger was approved. Minutes of August 31, 2022, upon motion by Pettinger, 2nd by Hartkopf were approved. Carried unanimously.

Treasurer Tracey Marshall submitted a parcel that is now owned by political subdivision of the City of Anita, Iowa for which tax statements were issued for which "taxes were owing...acquired by....a political subdivision". Taxes have not been paid; therefore "the board of supervisors shall abate all of the taxes". (Iowa Code 445.63)

Motion by Green, seconded by Hartkopf: Resolved to abate taxes, penalties, interest, costs and fees on parcel 325007568003020 and to direct the treasurer to strike from the tax books the reference to those items in accordance with Iowa Code 445.63. Absent from vote was Steve Baier. Carried unanimously.

County Engineer Trent Wolken reviewed activities including the bridge collapse that occurred on September 8, 2022. The DOT Officer investigating the incident noted that the vehicle was not permitted to cross the bridge. The Engineer is currently waiting for the bridge inspection team before deciding between a couple of options on how to repair the bridge. Supplies are still in demand and could affect the bridge repair being finished in a timely manner. Financing of the bridge repair prior to the reimbursement from the company was also discussed.

The Board received a resignation from Sara Harris, Cass County Auditor; the letter states her last day is September 12, 2022. The board did not accept her resignation date; this matter is tabled until the next meeting after HR counsel can advise.

Michael Clancy, of Renodry USA, presented a report on his findings on the moisture issue of the Courthouse. The moisture that the courthouse is having is called "Rising Damp Moisture". He is proposing technology that would be installed into the building in which will dehydrate the walls. There is a three year dry out guarantee with a 25-year warranty with this product. Work on the building could start next week with minimal interruptions to the building. Motion by Green, seconded by Hartkopf to accept the project at \$19,285.00 from Renodry USA with work beginning on September 21, 2022. This estimate and project does not include the Sheriff's Office or the Jail area of the Courthouse. Motion approved. Carried unanimously.

During the June 8, 2022 meeting it was approved to award ARPA funds to the local fire departments. It was decided to give each of the fire departments \$25,000.00 over the next three years. The time has now come to disburse the FY22/23 payment to the seven departments (Anita Fire Department was excluded due to them being given \$65,000.00 prior). Motion by O'Brien, seconded by Hartkopf for Resolution Allocating American Rescue Plan Act Funds 2022-045 was approved. Roll call vote, all ayes.

Cass County Department of Human Services has requested permission from the Board to lease two new copier machines. Motion by Green; seconded by O'Brien was approved. Carried unanimously. A vacancy exists on the Bear Grove Township board of trustees. An application for the position is now on file. Motion by Pettinger, second by Green: to appoint Ken Vogl as Bear Grove Township Trustee starting on January 1, 2023, for the remainder of the four-year term ending 12/31/2024. Carried unanimously. Committee reports: Hartkopf-Zion; Green-Landfill and 911 Center.
