Cass County Board of Supervisors

Tuesday, January 17, 2023

The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the board room at the courthouse with members present: Steve Baier chair; Stephen Green, Wendy Richter, Mark O'Brien and Bernard Pettinger. Absent: none.

Baier called the meeting to order at 9:02 a.m.

O'Brien moved, Pettinger seconded, to adopt the agenda as amended. All ayes. Motion carried.

Pettinger moved, Green seconded to approve the January 10, 2023 minutes. All ayes. Motion carried.

Jotham Arber gave the monthly Cass/Guthrie County Environmental Health report.

Ray Ostrus, Franklin Township Trustee, discussed Franklin Township contributing to the Wiota Fire Department and the county also contributing ARPA funds to the department.

Green moved, Pettinger seconded, approval of Resolution 2023-01, Livestock Facility Construction Evaluation and use of the Master Matrix. All ayes. Motion carried.

Green moved, Pettinger seconded, adopting changes to the employee handbook and distributing it to all employees electronically for department heads to print. All ayes. Motion carried.

Micah Lee presented the quarterly Cass County Conservation report.

County Engineer Trent Wolken reviewed current road and equipment projects.

O'Brien moved, Green seconded, appointing Atlantic Mayor Grace Garrett to Southwest Iowa Planning Council for 2023 and City Administrator John Lund as alternate. All ayes. Motion carried.

Pettinger moved, Green seconded, appointing Chelsea McCunn to the County Zoning Board of Adjustment (Iowa Code 335.11). All ayes. Motion carried.

Pettinger reported on the CADCO meeting. Baier reported on an email he received from the DNR regarding the Willow Heights lagoon. The lagoon was permitted on April 3, 1985 and the permit was discontinued in 1989 based on an understanding that the lagoon did not discharge. What appeared to be a discharge pipe was discovered upon inspection and an licensed engineer may be required to evaluate the system; however, the top of the discharge pipe was not found, so it may be that the pipe could be capped.
