The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the board room at the courthouse with members present: Steve Baier chair; Stephen Green, Wendy Richter, Mark O'Brien. Absent: Bernard Pettinger.

Baier called the meeting to order at 9:00 a.m.

Green moved, Richter second, to adopt the agenda. All ayes. Motion carried.

Richter moved, O'Brien second to approve the February 7, 2023 minutes. All ayes. Motion carried.

Public comments: Craig Meyer clarified that no one asked him to speak at last week's meeting about the wage difference between county and city truck drivers' wage difference.
