## **Cass County Board of Supervisors**

Tuesday, March 14, 2023

The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the board room at the courthouse with members present: Steve Baier chair; Stephen Green, Wendy Richter, Mark O'Brien and Bernard Pettinger. Absent: none.

Baier called the meeting to order at 9:04 a.m.

Pettinger moved, O'Brien second, to adopt the agenda as amended. All ayes. Motion carried.

Richter moved, Pettinger second, to approve the March 7, 2023 minutes, All ayes, Motion carried.

Judy Marnin, with Cass County Committee on Aging, presented a history of the committee and a current report on their activities, along with a budget request for the usual amount of \$7446 that is included in their by-laws.

Mark Knudsen presented the secondary roads weekly report.

Green moved, O'Brien second, approving Tony Gustafson as Operator I at \$22.50 per hour. All Ayes. Motion carried.

Jeff Clayton, with Holmes Murphy, presented services they could provide regarding employee benefits.

O'Brien moved, Pettinger second, to approve a two-year contract with Green Acres Lawn and Landscaping to remove snow for \$75 and apply salt for \$75 from the courthouse, \$50 for 707 Poplar and \$75 at the annex facility effective July 1, 2023. All ayes. Motion carried.

Green moved, O'Brien second, to approve a two-year contract with Cook Sanitation for the courthouse, 707 Poplar and the annex facility for \$195 per month effective July 2, 2023. All ayes. Motion carried.

Pettinger moved, Green second, to approve a two-year contract with Green Acres Lawn and Landscaping for seasonal lawn services including fertilizer, chemical sprays, etc. at the courthouse, 707 Poplar and the annex for \$225 effective immediately. All ayes. Motion carried.

Pettinger moved, O'Brien second, to change Drew Williams' effective date as Victoria Township Clerk from March 1, 2023 to February 15, 2023. All ayes. Motion carried.

Richter reported she attended the Healthy Cass meeting. Baier reported on the Golden Hills meeting.
