Coordinator's Report: Mike Kennon reported the Motorola enhancement project is still scheduled to be completed in March. Kennon also reported that tower rent has increased for the Oxford Tower. It is the only radio structure in the County where we pay any rent. It holds the Sheriff's Office VHF Repeater as well as the Fire VHF Repeater. The County has long hoped that we could migrate the equipment to the DOT tower at the intersection of Oxford Rd and Hwy 71. Kennon said that we will continue to work with the DOT to try to make this happen.

Kennon said that the current 911SB Fund balance stands at nearly \$250,000. This sounds like a lot of money, and it is, but replacing/fixing equipment and maintenance contracts are very expensive for 911.
