Coordinator's Report: Mike Kennon reported that there is an effort to declare "EMS as an Essential Service". RAGBRAI will be coming through Cass County July 22/23. Overnighting in Atlantic and potentially passing through many small towns in Cass County.

The current 911SB Fund balance stands at nearly \$350,000. This sounds like a lot of money, and it is, but replacing/fixing equipment and maintenance contracts are very expensive for 911.

Old Business: None.

New Business: Kennon said that there is a need to purchase and install equipment in the Communications Center that will allow Dispatchers to monitor video feeds from area school buildings. A modest computer and a large screen TV are needed for Sean (IT) to complete this project.

It was pointed out that the Atlantic Educational Opportunity Center did not receive a SEARS 700Mhz radio like all other school buildings in Cass County. It was suggested that we talk with the Atlantic Schools to determine and confirm there is a need for a radio in that location. We can consider purchasing a 700Mhz radio at our next regular meeting in April.

M/S/C Green / Schmitt to approve purchase of equipment and installation to allow monitoring school video feeds. Carried unanimously.

There were no public comments or concerns.
