Minutes Cass County Board of Supervisors Tuesday, August 1, 2023

The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the board room at the courthouse with members present: Steve Baier, chair; Stephen Green, Wendy Richter, Mark O'Brien and Bernard Pettinger. Absent: none.

Green moved, O'Brien second, to adopt the agenda as amended. All ayes. Motion carried.

Richter moved, O'Brien second, to approve the July 25, 2023 minutes. All ayes. Motion carried.

O'Brien moved, Pettinger second, to approve Class C Retail Alcohol Licenses for Olive and Twist LLC from August 3-7, 2023 and Quiet Creek Cabins, LLC from August 21, 2023 to August 20, 2024. All ayes. Motion carried.
