Minutes Cass County Board of Supervisors Tuesday, September 3, 2024

The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the courthouse board room with members present: Steve Baier, chair; Stephen Green, Wendy Richter, Mark O'Brien and Bernard Pettinger. Absent: none.

Green moved, Pettinger second, to adopt the agenda as amended. All ayes. Motion carried.

Richter moved, O'Brien second, to approve the August 20, 2024 minutes. All ayes. Motion carried.

Richter moved, O'Brien second, to approve the annual auditing firm contract with Gronewold, Bell, Kyhnn & Co. P.C. for the fiscal year ending June 30, 2024. All ayes Motion carried.

The board discussed an ARPA funding request from the Atlantic Public Library for roof repairs. The request form indicated the cost will exceed \$100,000. The balance of ARPF funds is approximately \$20,000. Before making a decision, the board will request more information from the library.

Green moved, Pettinger second, to abate taxes on 309 4th Street in Griswold, as recommended by the assessor due to the property owner being a disable veteran who qualified for the abatement at their new residence. All ayes. Motion carried.

The board discussed signing a software support agreement with ReNewGov, but took no action. A committee will be established to make recommendations to the board on possible action in the future.

Trent Wolken, County Engineer, reviewed current road and equipment projects.

Pettinger moved, Green second, to appoint Jeals Brines, DO and Jill Pollpeter, MD as Medical Examiner Deputies at the request of Medical Examiner Elaine K. Berry, MD. All ayes. Motion carried.
