Minutes Cass County Board of Supervisors Tuesday, March 18, 2025

The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the courthouse board room with members present: Steve Baier, chair; Stephen Green, Wendy Richter, Mark O'Brien and Bernard Pettinger. Absent: none.

Pettinger moved, Green second, to adopt the consent agenda including:

- Minutes of the March 4, 2025, regular board meeting minutes,
- Minutes of the March 4, 2025, budget work session,
- Claims.

All ayes. Motion carried.

Richter moved, Green second, to approve the Iowa Department of Transportation Federal-Aid Agreement for a County Highway Bridge Program, Project No. BROS-CO-15(89)—8J-15, Iowa Department of Transportation Agreement No. 4-25-S-007, on Keystone Road over an unnamed creek on NLINE. All ayes. Motion carried.

O'Brien moved, Pettinger second, to approve wage increase for secondary roads employee Tucker Sager from \$25.30 to \$25.80 following completion of the new hire probationary period in accordance with the employee agreement. All ayes. Motion carried.

At 9:05 a.m., Baier recessed for a joint public hearing with the Adair County Board of Supervisors on vacating and closing a section of road described as:

That portion of 780th Lane (AKA Union Ave., AKA Adair-Cass Ave.), established as Road #2 on January 7th, 1882 (See Cass County Road Record Book North Half, Grant Township, Section 1) with improvements in 1957 (recorded in Book 371, Page 132), commencing at the southern right of way limits of 350th Street/Akron Road and being 33 feet south of the northwest corner of Section 6, Summit Township (T-77N, R-33W) also being the northeast corner of section 1, Grant Township (T-77N, R-34W), thence running southerly along the east line of said Section 1, a distance of about 2,034 feet, to a point where Adair-Cass Avenue terminates (since 4-5-1961). Said portion is 66 feet wide and the total length of Adair-Cass Avenue to be vacated is about 2,034 feet.

Pettinger moved, Green seconded, to close the public hearing. All ayes. Motion carried. At 9:09 a.m., Baier closed the public hearing.

O'Brien moved, Green second, to approve Resolution 2025-12 Vacating a County Road Easement (780th Lane). Ayes: Baier, Pettinger, Green, Richter, O'Brien. Nays: None. Motion carried.

At 9:10 a.m., Baier recessed for a public hearing to consider vacating and closing a section of road described as:

That portion of Quebec Lane, established on November 9th, 1953 as Road # 5 of 1953 (See Cass County Road Record Book South Half, Massena Township, Section 27), commencing at the west right of way limits of 760th Street near the East 1/4 corner of Section 27, Massena Township (T-75N, R-34W), thence running westerly, along the Quarter line of said Section 27, a distance of about 1/4 mile to a point where the road terminates (at road vacation #4 of 1953). Said portion is 66 feet wide and contains about 1.95 acres of road right of way in Cass County. The total length of Quebec Lane to be vacated is about 1,287 feet. Richter moved, Pettinger second, to close the public hearing. All ayes. Motion carried. At 9:11 a.m., Baier closed the public hearing.

Green moved, O'Brien second, to approve Resolution 2025-13 Vacating a County Road Easement (Quebec Lane). Ayes: Baier, Pettinger, Green, Richter, O'Brien. Nays: None. Motion carried.

Green moved, Pettinger second, to approve a lease agreement with MDA Financial for the suite located in the basement of 707 Poplar, including the space formerly leased to Industrial Fluid Management, for \$600 per month, including utilities, for three years. All ayes. Motion carried.

The board discussed revising the indigent remains disposition policy. Discussion included reducing the amount the county pays funeral homes for indigent remains disposition and restricting the service to cremation. Input was received from funeral directors but no action was taken.

O'Brien moved, Richter second, to approve Resolution 2025-14 Amending the Secondary Roads Five Year Construction Program by moving Project Number BROS-C015(85)—8J-15 TPMS No. 55058, Bridge #73 from 2027 to 2025. The amendment is a result of NEPA Clearance sooner than anticipated. Ayes: Baier, Pettinger, Green, Richter, O'Brien. Nays: None. Motion carried.

O'Brien moved, Richter second, to approve plans and specifications to replace Cass County Bridge #73 on 620th Street, Project No. BROS-CO15(85)—8J-15. All ayes. Motion carried.

Green moved, O'Brien second, to approve plans and specifications for HMA Resurfacing/CIP Recycling on N-28 south of Highway 92 to the county line, Project No. STP-X-CO15(87)—5E-15. All ayes. Motion carried.

Secondary Roads Maintenance Superintendent Mark Knudsen reviewed secondary roads projects.

The board considered options to handle employee use of county vehicles. No action was taken.
