Cass County Board of Supervisors Tuesday, April 1, 2025

The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the courthouse board room with members present: Steve Baier, chair; Stephen Green, Wendy Richter, Mark O'Brien (by phone) and Bernard Pettinger. Absent: none.

Richter moved, Pettinger second, to adopt the consent agenda including:

Pettinger moved, Green second, to proclaim the month of April as Child Abuse Awareness Month and allow the Child Abuse Prevention Council to set up a display table in the hallway of the courthouse. All ayes. Motion carried.

Green moved, Richter second, to set the date and time of public hearing on the proposed Fiscal Year 2025-2026 proposed budget for 9:00 a.m. on April 22, 2025. All ayes. Motion carried.
