The Cass County Board of Supervisors met in regular session at 9:00 a.m. in the courthouse board room with members present: Steve Baier, chair; Stephen Green, Wendy Richter, Mark O'Brien and Bernard Pettinger. Absent: none.

O'Brien moved, Green seconded, to adopt the consent agenda including:

Green moved, O'Brien seconded, to approve the planned improvements of Landus' property pending a favorable ruling by the Board of Adjustment for the property as follows:

As part of Landus' ongoing effort to better serve their farmer owners in the Cass County and surrounding County areas, Landus has recognized a shortfall in storage space for anhydrous ammonia at the newly constructed facility South of the Landus Facility (formerly Wickman Chemical) located at 53597 650th Street, Atlantic, Iowa 50022. The newly constructed NH3 facility with a 72,000-gallon NH3 tank is positioned just west of the Landus building at 53751 650th Street, Atlantic, Iowa 50022.

Landus is proposing to add a 90,000-gallon NH3 tank that will be relocated from a facility in Southern Minnesota and place it just West of the existing 72,000-gallon tank. The total capacity for the site would be 162,000 gallons. According to the Iowa Department of Agriculture and Land Stewardship, Landus is required to maintain 50-foot set back from the property line and maintain a 600-foot radius from any residential structure. Attached is a drawing showing location of tank with the setback and radius requirements, both of which are met with the installation of this tank. IDALS has already inspected the site and has no issues with adding the additional tank.

Jotham Arber, Executive Director of Cass/Guthrie County Environmental Health, presented the monthly report.

Anita Economic Development presented a request for a low-interest loan of \$250,000 - \$275,000 to install homes on 80% of the former trailer park which is now owned by Anita Economic Development. The board will consider acting on this request at their next regular meeting.
