Pettinger moved, Richter second, to approve Resolution 2023-10 Amending Cass County's Official Publication to Atlantic News Telegraph and use Anita Tribune and Griswold American as Information Sources for Constituents. Ayes: Pettinger, Green, Richter, O'Brien, Baier. Nays: none. Motion carried.

O'Brien moved, Richter second, to approve Resolution 2023-11 Supporting the Present Local Option Sales and Service Tax. Ayes: O'Brien, Baier, Green, Richter. Nays: none. Motion carried. Pettinger was no longer present to vote.

County Engineer Trent Wolken reviewed current road and equipment projects.

Richter moved, O'Brien second, to appoint Norma Hemphill to Southern Iowa Regional Housing Authority. All ayes. Motion carried.
