Pettinger moved, Green second, to approve a \$14 tax penalty waiver for the Valley Business Park property taxes that were due March 31, 2023, and that had been paid by the buyer rather than the seller. Valley Business Park will pay the taxes and Cass County Treasurer will reimburse the buyer. Ayes: Baier, Green, Richter, Pettinger. Nays: O'Brien. Motion carried.

Richter moved, Pettinger second, approval of Resolution No. 2023-15 Appointment of Stephanie Witzman as Civil Process Server. Ayes: Baier, Pettinger, Green, Richter, O'Brien. Nays: None. Motion carried.

O'Brien moved, Pettinger second, to appoint Tabetha Smith RN as additional medical examiner investigator. All ayes. Motion carried.

Green moved, Richter second, to approve auditor's office hire of Hannah Richter as Accounts Payable/Elections Administrator at \$18.00 per hour. All ayes. Motion carried.

Supervisor reports included Baier on juvenile detention and Golden Hills.
