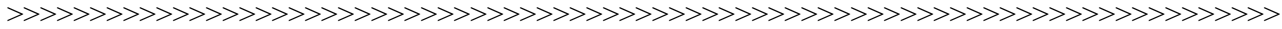




Sheriff’s Sergeant: Kyle Quist (78% of sheriff) \$63,726.00/year.

Deputy Shiels is also a ‘dog handler’. The county sheriff has requested that additional supplement pay be paid for such duty.

Motion by Green, 2nd by Pettinger: For fiscal year 2021 to authorize supplement pay [IOWA CODE 331.904(2)(e)] to Sheriff’s Sergeant Tyler Shiels at the rate of \$1,775/year for the additional dog handling duties. Carried unanimously.

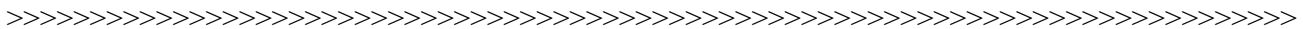

Motion by Pettinger, 2nd by O’Brien: to set the following schedule for sessions of the Board during the year 2021: Every Tuesday (unless otherwise noted) and the last working day of each month. Sessions will begin at 9:00 a.m. unless otherwise noted in the agenda. Carried unanimously.

Motion by Hartkopf, 2nd by Green: to issue general checks twice monthly on the working day closest to the 15th and the last working day of month, unless otherwise authorized, and to hold over claims for payment to the next period if filed with the County Auditor less than three full working days before pay date; and to authorize the County Auditor to issue checks in accordance with section 331.506(3) Code of Iowa. Carried unanimously.

Motion by Green, 2nd by Hartkopf: to set 2021 per mileage fee to be charged by sheriff for civil process at the standard IRS per mile rate. Carried unanimously.

Motion by Green, 2nd by Hartkopf: to continue medical examiner's fee at \$200 per call (331.803 IA CODE). Carried unanimously.
